It is also understood and agreed that any Handbook cannot be exhaustive, so therefore the administration reserves the right to interpret the established standards of Newberry Academy in the best interests of the school and as such the members of the family agree to abide by such decisions.
- 3) That Newberry Academy has full discretion in the placement of students in terms of academic and extracurricular settings.
- 4) That Newberry Academy maintains the privilege to suspend or expel a student for any scholastic or disciplinary reason or cause and sufficiency of such reason or cause. Furthermore, the school maintains the privilege of full discretion with the disciplining of students, though not to include corporal punishment.
- 5) That the enrolled student has permission and authorization to participate in all school activities, potentially including athletics and other school-sponsored events and activities. This permission absolves the school of any and all liabilities stemming from an accident or injury that may occur during these school-sponsored and related events.
